AG25-3 and AG25-5 LED LIGHT FIXTURE - LIMITED FIVE YEAR WARRANTY

This Ag Lighting Innovations, LLC (AGLI) LED light fixture (AG25) is warranted to the end use buyer (BUYER), for a period of five years from the date of original purchase against all defects in material workmanship. Warranty information must be registered via a completed warranty card and copy of the BUYER original Sales Receipt at time of purchase. AGLI will confirm all warranty cards by email. This product is considered a consumable product and is at times used in extreme agricultural environments. Therefore, warranty will include a "Free Replacement Period" and a "Prorated Replacement Period". See below.

OUR GUARANTEE

AGLI will replace any AG25-3 and AG25-5 AGLI sells directly to the BUYER, in the event product fails due to defects in materials or workmanship, under normal installation, use and service, while under warranty. This warranty does not cover the exceptions listed below under, "WHAT IS NOT COVERED".

LENGTH OF WARRANTY

Warranty begins the day BUYER purchases the AG25, and expires at the end of the warranty period. This warranty is not transferable.

FREE REPLACEMENT PERIOD

Free replacement period begins the day BUYER purchases the AG25, and expires at the end of the "Free Replacement Period" which is 3 years (36 months) from the date printed on BUYER Sales receipt. When an AG25 is replaced during the "Free Replacement Period", the warranty remains unchanged, and continues on from the original date of purchase.

PRO-RATED REPLACEMENT PERIOD

Pro-Rated Replacement Period begins the day "Free Replacement Period" ends and expires 5 years from the date printed on BUYER Sales Receipt. The Purchase Price printed on BUYER Sales Receipt will be used to determine Pro-Rated discount. The Pro-Rated schedule is:

Year 4 (37-48 months): 40% of purchased price

Year 5 (49-60 months): 20% of purchased price

WHAT IS NOT COVERED

This warranty does not cover. failure due to misuse, moisture, electrical surge, abuse, modification, accident or collision, or improper installation. This AG25 is warranted only when installed in an AGLI approved lighting system which may include, among other local regulations, plastic electrical junction boxes/conduit, an approved LED Dimmer, an approved power surge protection device. Installation of this light fixture in any other application voids the warranty. THIS WARRANTY DOES NOT COVER LABOR, INCIDENTAL OR CONSEQUENTIAL DAMAGES SUCH AS PHYSICAL INJURIES, PROPERTY DAMAGE, LOSS OF TIME, LOSS OF USE OF THE FACILITY, INCONVENIENCE, OR ANY OTHER DAMAGE RESULTING FROM THE FAILURE OF THE LIGHT FIXTURE.

WHAT YOU MUST DO

In the event of a defect or malfunction within this period, the fixture will be repaired or replaced, at our option provided that it is returned with:

- 1. Return Authorization Number (RA). Call customer service for RA number. For RA number and questions, call customer service at 1-888-473-8816
- 2. Carefully package product and print RA + number on the outside of the carton.
