FIRST AID

IF INGESTED: Drink 1 or 2 glasses of water and induce vomiting by touching back of throat with finger. Do not induce vomiting or give anything by mouth to an unconscious person. Call a physician immediately.

IF ON SKIN: Remove contaminated clothing and wash affected areas with soap and water. Wash contaminated clothing before reuse.

IF IN EYES: Flush with plenty of water, call a physician immediately.

NOTE TO PHYSICIAN: Methomyl is a cholinesterase inhibitor. Atropine is antidotal. Administer intravenously or intramuscularly if IV injection is not possible.

ENVIRONMENTAL HAZARDS

Exposed surfaces treated with this bait are hazardous to birds and other wildlife. Do not apply directly to water. Do not apply where runoff is likely to occur. Do not contaminate water when disposing of equipment wash waters. Blue Streak is an advanced formula bait containing TRICOLURE sex attractant and feeding adjuvants which attract both sexes of the house fly and many other pest fly species including little house flies, flesh flies, blow flies, bazaar flies (*Musca sorbens*), and eye gnats directly to the bait.

DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

NOTE: This product may not be used (as either a scatter bait or in a bait station) around or inside homes or any other places where children are likely to be present. Residential use of this product is prohibited.

For use as a Scatter Bait: Use of Blue Streak as a scatter bait is limited to certain commercial agricultural production areas where children and pets are not likely to be present. Use only around hog houses, livestock barns, meat and poultry processing establishments, beverage plants, canneries and food processing establishments. Bait may be used on walkways in caged layer houses. Bait should be applied to specified areas of high fly population daily or as needed to reduce fly populations. Scatter bait from container or other device at the rate of approximately 4 ounces per 500 square feet of fly feeding surface. Do not allow food producing animals to have access to treated areas.

For Use in Bait Stations: For stables and other commercial (non-residential) use sites not specified above, Blue Streak must be used in a bait station. Fill bait chamber to bottom of hopper by pouring 2 ounces of bait into hopper. Use at the rate of approximately 2 bait stations per 500 square feet of fly feeding area. Bait stations must be inaccessible to children and food producing animals. Hang bait stations out of reach of children and food producing animals at a height of at least 4 feet above the ground.
