DIRECTIONS FOR USE

POULTRY, SWINE, VEAL, DAIRY, CATTLE, CANINE AND HORSE OPERATIONS: Use **BioCres** for cleaning broiler houses, brooders, layer houses, livestock barns, farrowing pens, foaling pens, stalls, calf hunches, pig parlors, kennels, poultry crates, animal transport vehicles and farm equipment. **BioCres** is recommended for use on surfaces such as concrete, wood, plastic, glazed tile, enameled and metal surfaces of livestock housing, handling equipment and transportation equipment.

APPLICATION INFORMATION: Remove all animals, poultry and feed from premises, trucks and enclosures. Remove all litter and manure from floors, walls and surfaces of barns, pens, stalls, chutes and other facilities occupied or traversed by animals or poultry. Empty all troughs, racks, and other feeding and watering appliances. Remove gross soil by hosing with water, brushing, vacuuming or

sweeping before using **BioCres**. Apply solution as a soft coarse spray or with a brush, sponge or mop. For hand use, wear rubber gloves. For maximum cleaning effectiveness, allow treatment to remain on the surface for at least 10-20 minutes before flushing with water. Spraying or misting of the product is not recommended unless the operator is protected from breathing the spray mist.

USE DILUTIONS FOR NORMAL CLEANING: Clean premises with **BioCres** at 0.5% solution (1 gallon in 200 gallons of water) (2 ounces per 3 gallons of water) (5 mL/L). Light to moderately soiled surfaces may be cleaned just once. After cleaning, follow-up with an application of an appropriate disinfecting solution.
