5. FIRE FIGHTING MEASURES

EXTINGUISHING MEDIA: Water spray, CO₂, foam, dry chemical.

UNUSUAL FIRE, EXPLOSION HAZARDS: Can burn in fire releasing irritating and toxic gasses due to thermal decomposition or combustion.

FIRE-FIGHTING PROCEDURES: Evacuate area and fight fire upwind a safe distance to avoid hazardous vapors and decomposition products. Cool closed containers exposed to fire with water spray. Dike and collect water used to fight fire. Foam or dry chemical extinguishing systems are preferred to prevent environmental damage due to runoff. 6. ACCIDENTAL RELEASE MEASURES

ACTION TO TAKE FOR SPILLS/LEAKS: Clean up spills immediately observing the precautions in Section 8 of this MSDS. Isolate the hazard area and keep unnecessary and unprotected personnel from entering. Do not walk through spilled material and avoid breathing vapors and skin contact. Do not allow material to enter streams, sewers or other waterways or to contact vegetation.

For large spills, material should be recovered. For small spills, absorb with absorbent granules, spill control pads or other absorbent material (e.g. sand, silica gel, acid binder, universal binder). Carefully sweep up absorbed spilled material and place in a properly labeled and covered container for disposal. Scrub contaminated area with soap and water and use dry absorbent granules to collect wash solution for disposal. Contaminated soil may have to be removed and disposed.

7. HANDLING AND STORAGE

PRECAUTIONS TO BE TAKEN IN HANDLING: Do not contaminate water, food, or feed by storage or disposal or cleaning of equipment. Avoid breathing dust or vapor. Avoid contact with skin, eyes and clothing. Remove and wash contaminated clothing before reuse. Wash thoroughly with soap and water after handling and before eating, drinking, chewing gum, or using tobacco.

SKIN PROTECTION: Long-sleeved shirt and long pants. Shoes plus socks.

HAND PROTECTION: Chemical-resistant gloves made of any waterproof material such as barrier laminate, butyl rubber, nitrile rubber, neoprene rubber, natural rubber, polyethylene, polyvinylchloride (PVC), or Viton.

EYE PROTECTION: Wear protective eyewear (goggles, face shield, or safety glasses).

RESPIRATOR REQUIREMENTS: A respirator is not required when handled under normal conditions. When handling in enclosed areas with inadequate ventilation, use a dust / mist filtering respirator (MSHA/NIOSH approval number prefix TC-21C).

11. TOXICOLOGICAL INFORMATION

ACUTE TOXICITY/IRRITATION STUDIES:

Chronic Toxicity In chronic dietary studies in rats and dogs exposed to imidacloprid, the target organs were the thyroids and/or liver.

Assessment Carcinogenicity In oncogenicity studies in rats and mice, imidacloprid was not considered carcinogenic in either species.

Reproductive & Developmental Toxicity **REPRODUCTION:** In a two-generation reproduction study in rats, imidacloprid was not a primary reproductive toxicant. Offspring exhibited reduced body weights at the high dose and in conjunction with maternal toxicity.

DEVELOPMENTAL TOXICITY: In developmental toxicity studies in rats and rabbits, there was no evidence of an embryotoxic or teratogenic potential for imidacloprid. In both species, developmental effects were observed only at high doses and in conjunction with maternal toxicity.

Neurotoxicity Neurotoxicity studies in rats showed slight behavioral and activity changes only at the highest dose tested. There were no correlating morphological changes observed in the neural tissues.

Mutagenicity The imidacloprid mutagenicity studies, taken collectively, demonstrate that the active ingredient is not genotoxic or mutagenic.

12. ECOLOGICAL INFORMATION

ENVIRONMENTAL HAZARDS: Do not apply directly to water, to areas where surface water is present, or to intertidal areas below the mean high water mark. Do not contaminate water when disposing of equipment washwaters.

This product is highly toxic to bees exposed to direct treatment or residues on blooming crops or weeds. Do not apply this product or allow it to drift to blooming crops or weeds if bees are visiting the treatment area. This product is toxic to wildlife and highly toxic to aquatic invertebrates.
