#### PRECAUTIONARY STATEMENTS

**CAUTION:** Avoid breathing dust. Use with adequate ventilation. Avoid contact with the eyes, skin, and clothing. Always wear impermeable gloves, chemical safety goggles, and protective clothing when handling this material. Wash thoroughly after handling. Do not eat, drink, or smoke in the work area. Keep product away from heat and flames.

FIRST AID: Have the product label available when seeking medical advice or treatment.

IF IN EYES: Immediately flush eyes thoroughly with large quantities of water for 20 minutes while holding the eye lids open to ensure the material is washed out. Remove contact lenses if present and easy to do. Get immediate medical attention.

IF ON SKIN or CLOTHING: Remove contaminated clothing. Wash contact area thoroughly with soap and water for several minutes. Get medical attention if irritation or rash occurs. Launder clothing before re-use. Get medical attention if irritation or rash occurs.

**IF SWALLOWED:** Do not induce vomiting unless told to do so by medical personnel. Keep the victim calm and warm. Get medical attention if symptoms develop.

**IF INHALED:** Remove to fresh air. If breathing is difficult or irritation persists, get medical attention.

PHYSICAL AND CHEMICAL HAZARDS: Do not apply on or around electrical wiring. Do not apply to hot surfaces or equipment.

STORAGE AND DISPOSAL: Do not contaminate water, food, or feed by storage or disposal. Store in original container at room temperature in a dry location inaccessible to children or animals. Do not reuse container. Rinse empty container and recycle or dispose in trash. Comply with state and local guidelines for disposal of unused product. Keep containers closed when not in use.

#### **Directions for Use**

For best results, before the application, turn off all ventilation and cooling fans in the area to be treated and leave the fans off until the powder has settled (can take up to 15 minutes). Wait until the product has settled to return to the site.

Naturganic Pest Powder can be applied manually or with a powered powder or dust applicator. If using a blower/duster, start with the throttle on idle and the metering dial mostly open, and adjust as needed to blow powder at appropriate rate. For example, on a Stihl backpack blower, the recommended settings are throttle at idle and metering dial at 5-6.

#### Application for Bed Bugs

Naturganic Pest Powder can be applied to control bed bugs while birds are present. Before treatment, turn off fans and leave off until the product has settled (about 15 minutes after application). Wait until the product has settled from the air to return to the area.

Apply at a rate of 4-6 lbs. of Naturganic Pest Powder per 1,000 sq. ft. of the facility. Make sure to apply to potential harborage areas, including gaps along walls, behind sheeting or framing, attics, around drop ceiling joints and above drop ceilings, gaps between walls, and nest areas, work rooms and equipment.

Repeat application of Naturganic Pest Powder every 4-6 weeks or reapply as needed for bed bug control.

#### **Application for Cockroaches:**

Apply at a rate of 4-6 lbs per 1000 sq. ft. of application area. Blow into studs, behind wall boards, into crawl and attic spaces, or other places where roaches can hide. Apply from high to low. Apply as needed for cockro

#### Application for Northern Fowl Mites

Apply at a rate of 4-6 lbs of Naturganic Pest Powder per 1000 sq. ft. of facility. Apply when birds are 25-26 weeks old; one week after first application, make a second application. Apply powder to birds and cages in each level of every row, ruffling feathers to penetrate.

Repeat application every 6-8 weeks in case of high infestation rate and every 3 months for maintenance, or as needed for mite control.

As part of a preventative program, after cleanout and washing of house, apply Naturganic Pest Powder into harborage areas such as nesting boxes, scratch areas, and attics at a rate of 4-6 lbs per 1000 sq. ft. of facility.
